Agitation For the Creation Of 31 More States: Politics Or Development?

Last week the Nigerian House of Representatives during its plenary session told the nation that it received the proposal for the creation of more states numbering thirty-one. Currently, Nigeria has a 36-state structure and if the proposed thirty-one are added the states will be 67. Nigeria started with three regions and has been restructured by the military and for over 64 years the agitation did not die down.

On February 5th, 2025 the House of Representatives Committee on the Review of the 1999 Constitution announced on Thursday, that it has received 31 proposals for the creation of new states across the six geopolitical zones.

Deputy Speaker Benjamin Kalu read a letter from the committee during plenary, outlining the conditions that must be met before any state creation requests can be approved.

According to the letter, the proposals include five from the North Central, four from the North East, five from the North West, five from the South East, four from the South-South, and seven from the South West.

Among the states being considered are Okun, Okura, and Confluence (Kogi); Benue Ala and Apa (Benue); FCT State; Amana (Adamawa); Katagum (Bauchi); Savannah (Borno); and Muri (Taraba).

The states also include New Kaduna state and Gujarat states from Kaduna state; Tiga and Ari from Kano, and Kainji from Kebbi state; Etiti and Orashi as the 6th state in the South East, Adada from Enugu, Orlu, and Aba from the South East.

They also include Ogoja from Cross River, Warri from Delta, Ori and Obolo from Rivers; Torumbe from Ondo, Ibadan from Oyo, Lagoon from Lagos, and Ogun, Ijebu from Ogun, Oke Ogun/Ijesha from Oyo/Ogun/Osun states.

According to the letter, Section 8 of the 1999 Constitution as amended outlines specific requirements that must be fulfilled to initiate the process of state creation.

The letter said "a request to the National Assembly for the purpose of creating a new state shall only be passed if a request supported by at least the third majority of members of the Senate and the House of Representatives and the House of Assembly in respect of the area, and the Local Government Council in respect of the area, is received by the National Assembly.

But in an exclusive interview with a renowned Nigerian Political Scientist at the Kano state college of Arts and Science, Dr. Kabiru Saidu Sufi said unless there is consensus the state creation exercise will be in futility.

"I think like you rightly said, state creation have become a recurring issue in Nigerian politics overtime there have been this agitation, the more states you create the more agitation, you are likely going to have from all quarters and this one is not a new one, and there have been the debate of whether the creation of states will be beneficial or not."

"The proponents in practice and in theory believe if you create more states, you are creating more avenues to which you will bring government closer to the people, because as it is, the size of some of the states is so large and they believe that if some of these states are broken down they will bring government closer to the people."

"There is also the issue of administrative efficiency, and you know some people that believe if you create more states these states are more viable, and you will have more administrative efficiency."

"Thirdly there are those who believe these states are serving as a future training ground for national leaders, so they will go to the federal level, and they say most of them start from the states, so some people believe that the more states you have the more training ground you are creating, for future leaders"

He however explained reasons why some people oppose the creation of additional states

"on the other hand there are those people who believe the creator of states is detrimental to political development, for example they believe you are further disuniting people than uniting them, the more states you have the more divided Nigerians are, so there are those who believe we should have few states and they say let's even go back to the regions, so that Nigerians will have more sense of unity."

"Some see the states as an avenue where money is being spent, rather than saving which they say we are creating avenues for spending more money than saving"

"There are those that see the more you create the states the more you are bringing further agitations, and there is even this debate whether it's possible to even create states under civilian dispensation especially taking into consideration the fact that in the past all states were created during the military regime"

"there is this issue of constitutional procedure of creating more states, which is not an easy exercise in which Section 19 has laid down procedures. You can amend the constitution for which you can create states and amend borders and this is a very conversant process ranging from getting the two third majority in the two federal chambers of the Senate and House of Representatives and then the two third majority of the 36 states houses of assembly"

"In some cases there are serious issues, and there is also involvement of getting the four fifth of the states Houses of Assembly and no matter one will look at it and see that it is not an easy exercise and is something that requires a very rigorous procedure and that may not necessarily be easy to satisfy and in that regard one can say is an exercise in futility."

"in addition no matter the agitation at the end of the day it does not become a reality and the only way we can make it a reality is to have a lead consensus and when the leadership of the country agree to the desirability of the creation of the states then probably they will find a way of making it easier and when there is no lead consensus you find it to be an exercise in futility."



Governor Yusuf Appoints Umar Farouk Ibrahim as Kano New SSG

Kano State Governor, Abba Kabir Yusuf, has appointed Umar Farouk Ibrahim as the new Secretary to the State Government (SSG).

The appointment was announced in a statement issued by the governor's spokesperson, Sunusi Bature Dawakin Tofa, on Saturday.

His tenure in this role showcased his strong leadership and administrative skills. Notably, he served as acting Secretary to the State Government during annual leaves in 2013 and 2014, underscoring the trust and confidence placed in him by the state leadership.



Ace Journalist, Sanda Adamu Tsafe Passes On

An ace journalist and former Federal Commissioner of the defunct National Electoral Commission Abuja, Alhaji Sanda Adamu Tsafe, has passed away.

In a Facebook post by one of his children, Mahmud Sanda Adamu, it was announced that his father died at Usmanu Danfodiyo Teaching Hospital Sokoto.

Alhaji Sanda Adamu worked with the Federal Radio Corporation of Nigeria (FRCN) Kaduna in the 1970s, during which late Sheikh Abubakar Mahmud Gumi cited him in his famous book "Where I Stand" as one of the journalists who contributed to the airing of the late Sheikh's preaching on Sashin Hausa Radio Nigeria Kaduna.

Late Sanda Adamu Tsafe was the manager of Rima Radio Sokoto during the controversy that trailed the appointment of the late Ibrahim Dasuki as the 18th Sultan of Sokoto during the administration of General Ibrahim Babangida.

The deceased is survived by wives, children, and many grandchildren.

His funeral prayers will take place by 1:00PM at Masjidu Darul Da'awah, Kaduna Road, Guiwa Low Cost, Sokoto.

Late Alhaji Sanda Adamu Tsafe also left behind one of his brothers, Alhaji Ali Adamu Tsafe, a former Commissioner of Water Resources and Information during the administration of Alhaji Mahmud Aliyu Shinkafi in Zamfara state.

His elder brother, late Alhaji Muhammad Adamu, died in the year 2015 in Kano.

One of his relations is Professor Yusuf Adamu of the department of Geography Bayero University Kano.



Military Needs 500,000 Personnel To Defeat Insurgency-Retired General

A former Provost Marshall of the Nigerian Army, Maj-Gen Pat Akem-Vingir (rtd), says the military needs at least 500,000 personnel to eliminate terror groups like Boko Haram and the Islamic State West Africa Province (ISWAP).

"Our army is small. We need to have an army of at least 500,000 personnel," the retired general said on the Friday edition of Inside Sources with Laolu Akande, a socio-political programme aired on Channels Television

The Nigerian military has about 230,000 personnel, according to the ranking platform, Global Fire Power. Maj-Gen Akem-Vingir said much of the successes of the military in the theatre of war in Nigeria's North-East zone have been lost because of the lack of manpower to hold the ground after clearance operations.

He said until there is sufficient manpower to secure territories after terrorist dislodgement, the blood-thirsty marauders would continue to regain those places.

He said, "When you are fighting insurgency, you must capture ground and hold it. It takes troops to do that. When you capture ground, then you build and hold so that people can resume their lives and there will be security but if you are clearing areas and you are not holding, then they (terrorists) will come back."

The retired general also said the government should not recognise the newly formed terror group Lakurawa wreaking havoc in the North-West geopolitical zone of the country. Maj-Gen Akem-Vingir described the Lakurawa group as "one small tiny group" seeking attention.

ICPC Arrests NSCDC Deputy Commandant and Former Navy Admiral Over Alleged N3 Billion Fraud

The Independent Corrupt Practices and Other Related Offences Commission (ICPC) has arrested Adam Imam Yusuf, a Deputy Commandant of the Nigerian Security and Civil Defence Corps (NSCDC) in Kogi State, over the alleged diversion of more than N3 billion.

Yusuf, who was at large until now, was taken into custody from his residence in Gwagwalada, Abuja, and is set to face prosecution.

ICPC investigations revealed that former Chief of Naval Staff Vice Admiral Usman Jibrin (rtd.), allegedly orchestrated the fraud through Yusuf and former Brigadier General Ishaya Bauka Gangum (rtd.).

The alleged scheme reportedly involved the diversion of public funds using 92 fictitious companies that were not registered with the Corporate Affairs Commission (CAC).

An investigation by the ICPC traced these funds to Lahal Integrated, Gate Coast Properties, and other affiliated companies, leading to the acquisition of over 18 properties including filling stations.

Four of these properties have been forfeited to the government so far, while legal proceedings continue over the remaining assets.

The ICPC is also intensifying efforts to apprehend other suspects at large.

Dangote Refinery Crashes Ex-Depot Price Of PMS To N890
