Kano Government Denounces Misrepresentation of Appeal Court Ruling on Emirship Tussle

The Kano State Government has condemned what it describes as "gross misrepresentations" surrounding the recent Court of Appeal ruling on the ongoing emirship dispute, urging the public to remain law-abiding while the case progresses to the Supreme Court.

In a joint press statement issued by the Attorney General and Commissioner for Justice, Haruna Isa Dederi, and the Commissioner for Information, Ibrahim Waiya, the state government clarified that the appellate court's ruling did not invalidate its previous decision to repeal the Kano Emirate Council Law of 2019.

"It has become necessary to once again address you and the general public to correct the speculative reports emanating from some quarters, apparently intended to create disharmony among the citizens of Kano," the statement read. The government recalled that on January 10, 2025, the Court of Appeal upheld the repeal of the controversial 2019 law, which led to the reversion of the emirship structure to its previous status. However, it noted that Alhaji Aminu Babba Dan'Agundi, who is challenging the repeal, had filed an appeal at the Supreme Court and secured a stay of execution.

"The respected panel of justices heard and granted the application for a stay pending the hearing and determination of the appeal before the Supreme Court. This is a normal and routine judicial procedure to maintain the status quo," the statement explained.

TThe Kano government expressed concern over what it termed misleading headlines and reports suggesting that the Court of Appeal had overturned its own ruling.

"It is worrisome seeing various captions and headlines deliberately intended to mislead the public by misrepresenting the facts. The judiciary, as a sacred institution, must be jealously respected and guarded for the preservation of peace and order in society," the government asserted.

The officials further clarified that the Court of Appeal had not reversed its January 10 ruling but had only granted a temporary stay of execution pending the Supreme Court's final decision.

"For the avoidance of doubt, the Court of Appeal that entertained the application of Alhaji Aminu Babba Dan'Agundi did not set aside its own judgment delivered on January 10, 2025. That judgment remains valid and subsisting until the Supreme Court determines the appeal," the statement emphasized.

The government urged Kano residents to disregard any provocations and continue to uphold peace, assuring them that legal experts were reviewing the court's ruling to determine the state's next course of action.

"We call on the general public to resist any provocation and continue to be law-abiding. The Kano State Government has already instructed its lawyers to closely study the outcome to determine the next line of action in accordance with our extant laws," the statement concluded.

The ongoing legal battle over the emirship structure in Kano has sparked significant political and public interest, with both supporters and opponents closely watching the case as it progresses to the Supreme Court.

Kano Task Force Committee Launches Mass Operations Against Thuggery, Substance Abuse

The Kano State Joint Task Force Committee on Peace Restoration and Youth Rehabilitation under the leadership of Dr. Yusuf Ibrahim Kofar Mata, conducted mass operations in Yakasai, Kofar Mata, Zango, Zage, Zanzado, Rimi Market, Shahuchi Park, Kano Line, Sharada, Ja'en, Dan Agundi and neighboring areas.

The Committee PRO, Comrade Ibrahim Abdullahi Waiya, the Hon. Commissioner of the Ministry of Information and Internal Affairs, in a statement on Saturday, said between the 13th and 14th of March, 2025, intelligence-led operations which were conducted at the criminal hideout and black spots resulted in the arrest of fifty-three (53) suspected thugs, drug dealers and recovered three (3) Parcels,

Fifty (50) wraps and other large quantity of dried leaves suspected to be cannabis sativa (Wiwi), two (2) Codeine syrup, two (2) tubes of rubber solution, one (1) gallon of suck and die, one hundred and five (105) pieces of suspected exol tablets, five (5) cutlasses, and two (2) scissors.

Others are two (2) clubs (Gora) and a bulk of suspected charms. According to the statement, during the operations, the Task Force recovered substantial quantities of cannabis sativa at some notorious drug joint in Zanzado, where a larger quantity of the substance was found.

Additionally, a delivery vehicle and five (5) cattle suspected to belong to an infamous drug dealer, were also seized at this location.

The statement further stated that all the suspects arrested would be charged in court upon completion of the investigation.

The success recorded in the two-day operations indicates a significant step in the ongoing efforts to combat thuggery and substance abuse in Kano State.

"The composition of the committee which brought together combined security agencies and Government functionaries is dedicated to sanitizing the streets of Kano and restoring peace to the communities.

"The Kano State Joint Task Force Committee remains steadfast and resolute in its mission to create a safer, drug-free and peaceful environment for the benefit of all the inhabitants in the State," the statement added.




Dep. Sen. President Received Kano SSG, Commissioner Sacked By Gov. Yusuf

Biafran Rebels Kill Cameronian Soldiers In Bakassi

Five members of Cameroon's Rapid d'Intervention Battalions (BIR) were reportedly killed Friday morning, March 14, 2025, in the Bakassi Peninsula during an attack by Biafra separatist groups.

Sources close to the groups revealed that the assault was carried out by the Black Marine, the largest faction and the Dragon Fighter Marine afiliated with the Biafra Nations League (BnL).

"At around 6:00 am on Thursday, the group launched explosives, hitting their targets and neutralizing two warships," the sources claimed.

This marks a violent resurgence months after the arrest of Simon Ekpa, with insiders citing lack of funds as a reason for the group's previous inactivity.

Reacting to the attack, a source as reported by guardian said, "The warships have been withdrawn. The situation is tense, and our men are fully back in action."

BnL leader, Princewill Chimezie Richards said, "Biafra has come to stay in Bakassi not even Cameroon can stop us."

Pro-Wike lawmakers adjourn indefinitely ahead of Fubara's budget presentation

The faction of the Rivers State House of Assembly led by Martin Awaehule has adjourned its plenary indefinitely.

The decision was taken during a plenary session held at the assembly quarters in Port Harcourt on Friday.

The move comes just 24 hours after Siminalayi Fubara, governor of Rivers state, wrote to the assembly, requesting a new date for the presentation of the 2025 appropriation bill.



Ramadan: Speaker Abbas's aide donates cash to Dala LG APC Leaders, Supporters

Hon. Abubakar Aminu Ibrahim, the Senior Legislative Aide (SLA) to the Speaker of the House of Representatives, Tajuddeen Abbas, has donated cash to APC leaders and supporters in Dala Local Government to support them during Ramadan.

Nigeria, other African countries committed to energy transition amid global push for net-zero emissions – Veheijen

The Federal Government has reaffirmed its commitment to creating an enabling environment for hydrocarbon investments to address energy poverty, emphasizing that Africa is not a net contributor to global emissions.

The Special Adviser to President Bola Ahmed Tinubu on Energy, Olu Verheijen, made this statement on Tuesday in Houston Texas, United States during a session at CERAWeek by S&P Global, themed "Policy and People: Pathways to a Just Transition."

The session, chaired by Vera Blei, Head of Market Report & Trading Solutions at S&P Global, featured key speakers including Scott Tinker, CEO of Tinker Energy Association, and Sunita Narain, Director-General of the Centre for Science and Environment.

Nigeria, along with other African and middle-income countries, continues to advocate for a just energy transition amid the global push for net-zero emissions. Under its "Decade of Gas" initiative, the Nigerian government has adopted natural gas as a transition fuel to support economic growth while reducing carbon emissions.

Verheijen highlighted that Africa and other low-income countries contribute only about 3–4% of global greenhouse gas emissions, in contrast to China and the United States, which account for approximately 30% and 13% of global CO₂ emissions, respectively.

Together, both countries are responsible for nearly 40% of global emissions.

Creating an Attractive Investment Environment, Verheijen emphasized Nigeria's commitment to fostering a stable investment climate and addressing climate-related risks through clear and transparent policies.

"In Nigeria, we are ensuring that we create an enabling environment for investments. On climate change, we recognize the importance of risk perception in our markets and are committed to transparent policies that stand the test of time, enabling the deployment of capital," she stated.

KSIP Staff Raise Concerns Over Non-Implementation of N71,000 Minimum Wage, Seeks Kano Government Intervention

Employees of Kano State Investment and Properties (KSIP) have raised concerns over the non-implementation of the newly approved N71,000 minimum wage in their salaries.

The Kano State Executive Council, led by Governor Abba Kabir Yusuf, approved the wage increase, scheduled to take effect from November 2024. However, KSIP workers are yet to receive the revised salary, despite the growing economic pressures caused by inflation.

Reports indicate that KSIP's Managing Director, Auwalu Muktari Bichi, has already adjusted his own salary in line with the state government's new policy, while the same adjustment has not been extended to other employees.

A source within KSIP questioned the Managing Director's decision, stating:

"How can he claim the budget has not been approved, yet he increased his own salary? This is unfair to the workforce."

Employees argue that, as a corporate entity operating a five-day workweek with professional standards, they are entitled to the salary increment approved by the governor.

Discontent among KSIP employees has fueled calls for a thorough investigation into the administration of Auwalu Muktari Bichi. Allegations against him include frequent threats of dismissal against staff over minor issues not classified as violations under the company's Conditions of Service.

There are also claims that he has involved family members in the company's operations, a situation reportedly well-known within KSIP. The Kanawa Taxi Association controversy, already under investigation by the state's anti-graft agency, has been cited as another instance of alleged misconduct.



Kano To Strengthen Collaboration With Online Media

Kano State Commissioner of to Information and Internal Affairs, Comrade Ibrahim Abdullahi Waiya, has reaffirmed the government's commitment to working closely with online media organizations in the state.
